NOTICE TO EXAMINERS

1. The apprentice will not be allowed at a show to act as a steward during the judging of the same breed of which he is to be examined.
2. No resource of whatever nature will be allowed during the practical examinations (note, handbooks, poultry standards, etc.).
3. While proceeding with the examination, the examining judges should satisfy themselves that the apprentice is proficient in the under mentioned aspects. Points should be allocated to each aspect and the apprentice must obtain eighty percent (80%) to be accepted as a judge in this particular breed.
4. This examination will consist of an oral and a practical section and should be handled by at least three (3) judges appointed from any Panel. One examination judge should be qualified in the particular breed in which the examination is taken, if possible. The judging of the breed must be completed before the apprentice commences with his examination.
5. The oral examination implies a thorough discussion of the type, size, colour and condition of entries selected by the examiner, without removing them from their pens. During this discussion no bystanders will be permitted.
6. At the end of this session the apprentice must judge at least one entry in each class and variety according to the scale of points as stipulated in the SA Book of Standards. The results obtained after the allocation of points by the apprentice will be evaluated and discussed with the apprentice by the judges.
